I am directed to state that on basis of request made by the institution, the All India Council for Technical Education has accorded conditional approval to N.D.M.Y.P.'s Institute of Pharmaceutical Sciences, c/o Medical College, Adgaon, Nashik, Maharashtra for establishment of diploma institution for conducting D.Pharmacy course with an annual intake of 60 (sixty) seats for the session 1996-96. This approval has been accorded in place of B.Pharmacy course accorded to the trust vide our letter Ref. 740-89-133(P)/RC/95 dated 30/6/95 and hence approval of B.Pharmacy course stands withdrawn.

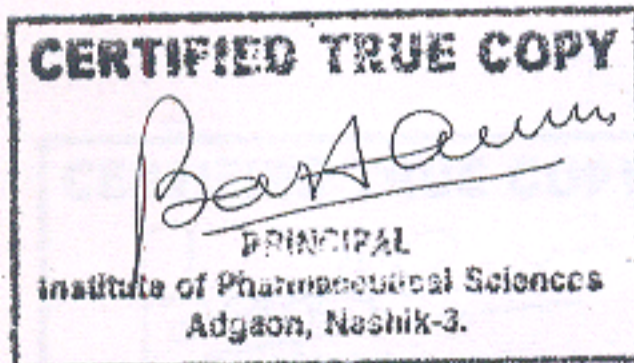

This approval have been accorded subject to fulfillment of specific and general conditions as listed in Annexure I & II respectively. You are requested kindly to take further action.

The admissions will be made in accordance with Regulations notified by the AICTE vide GSR 1476(EI) dated 20.05.1994 based on the Hon'ble Supreme Court Judgment dated 04.02.1993 with regard to KP (C) No. 607 of 1992 in the case of Duni Krishnan JP and others etc. v/s. State Government of Andhra Pradesh and others etc. and later judgments. No Management/Institute/Trust or Society shall announce admissions directly under any circumstances. Any action contrary to this provision taken by the institute will make it liable to be derecognised.

Further in the event of infringement/contravention or non-compliance of the conditions prescribed by the AICTE by December 1995, the Council shall take further action to withdraw approval to these cases for admission during 1996-97 and the liability arising out of such withdrawal of approval will be solely that of Management/Trust/Society and/or Institutions.

You are also requested to kindly monitor the progress made by these institutions for fulfillment of conditions laid down in this approval for extension of approval and keep the MRC and AICTE informed.
